DTC monthly Board Meeting on Wednesday 5 August 2015

Board members in attendance were: Dennis Anderson, Janine Carlson, George Haver, Cheri Herman, Dale Hersch (PT), Kelli O'Neill, Grace Vaughn, and Frans de Waard. The meeting was called to order at 6:10 pm at the Clubhouse. Other members in attendance were: Steven Asercion, Rick Becker, Dave Cone, Toshi Hayashi, Jan Husbeck, Peggy Leander, Joe Lerch, Norma Rice.

1. Previous Minutes of Meeting

The minutes of the July Board meeting were approved without changes.

2. President's Report

George and Kelli reported on their second meeting with George Parker (called by him), the current Director of DJUSD facilities, in particular that:

- ✓ George Parker reported that he had asked the city to resurface the Community Courts, in accordance with the Memorandum of Understanding (MOU). Note: In accordance with the Agreement between the DJUSD and the City, dated 28 July 2005, concerning tennis courts use and maintenance, resurfacing of tennis courts is not "routine maintenance", but a capital expense. On this basis, the City declined to do the resurfacing.
- ✓ In addition, the City proposed the DJUSD to terminate this agreement. It appears that one reason for this termination is that the City does not want to maintain the related insurance.
- ✓ On this basis, George Parker proposed a solution, which would be to lock courts 1 7, and leave courts 8 – 12 open to the public. Courts 1 – 7 would remain accessible to Dale Hersch and DTC members.
- ✓ George Parker also mentioned "Megan's law" as a factor in locking courts 1-7. Based on this information, there was a general discussion, of which the following highlights:
- √ The DJUSD has traditionally been an "Open Campus" for sport facilities, including soccer, basketball, etc. and it was questioned if all those facilities will also be locked.
- ✓ In accordance with the MOU, both the DJUSD and the City maintain insurance. It is not clear how locking courts 1 7 would solve the problem that the City would stop their insurance. Regarding this issue, the DTC could propose to the City to take out this insurance (depending on cost). This insurance would then necessarily also apply to the general public, but this would still be in line with the DTC mission.
- ✓ The DTC needs to talk to the City to understand their position, in particular if this change proposed by the City applies only to tennis.
- √ If courts 1 7 are locked, the DTC position will be not to use them either, even though
 that might be possible. Using those courts would be detrimental to the DTC reputation,
 by making access exclusive.
- ✓ It is not clear if locking courts will also apply to the other DJUSD tennis courts in town. Based on the above considerations, the board agreed to first meet with the City and discuss these issues. Once there is a more complete understanding, the DTC would again meet with George Parker.

On another issue, Kelli reported that she went to a meeting of the City Council which had Pickle Ball striping for tennis courts on the agenda. It turned out that this had already been done on the Slide Hill Park and North Davis courts.

Frans reviewed the status of the House Rules. There are still a few details to be worked out, but it was agreed to post the draft rules in the new display box.
