### 1 TREASURERS REPORT

# 5. High School Court Repairs

The Cabana Bench and Fence Canopies will have matching forest green canopies.

Next step is to contact DJUSD for their approval and to request that they cover the installation costs. ACTION ITEM: George to contact DJUSD to determine if the DJUSD will be responsible for the cost of securing the benches and canopy installation.

The canopy bench will likely require direct burial, which entails gouging out footers and pouring cement to anchor bench to.

A motion was made by Grace as follows: To allocate \$3,018.39 including shipping for the purchase of one 6x3 foot cabana bench to be installed between the north courts 10 and 11 and two cabana fence mount covers over the end benches dependent on the DJUSD paying for installation or upon the Club paying for installation not to exceed \$1,500.00. The motion was seconded by Chris and passed unanimously.

#### 4 CLUBHOUSE AND COURT MAINTENANCE AND REPAIRS

# a - New Refrigerator

After discussion the Board suggested that the membership be asked if a refrigerator was available to donate to the Club. New refrigerator costs around\$300-\$400 from Sears Outlet stores

ACTION ITEM: Grace to send out e-mail to members seeking donation of a gently used refrigerator and to contact Dennis

# **b- Clubhouse Painting**

Dennis reported that he had researched paint types and recommended Behr Paint and Primer at a cost of about \$166.00 per 5 gallons and thought that 10 gallons would do the trick – matched as closely as possible to the existing color. Estimated costs of supplies for project was \$500. He indicated that he has a paint sprayer, tarps, roller and pole for paint project.

A motion was made by Margo and seconded by Chris to authorize the expenditure of up to \$500 at Home Depot for Behr paint and primer and other miscellaneous painting supplies as needed for the project.

Dates of May 23-25 selected for painting project.

ACTION ITEM: Grace to send out info on Clubhouse painting to membership and solicit volunteers ACTION ITEM: Dennis to secure painting supplies, coordinate volunteers and oversee painting project.

# c- New garbage can

**W**hile at the meeting it was noticed that the existing interior garbage can has a broken lid. Dennis to purchase new can as part of painting supply purchases.
